## **STRATEGIES:**

- Uncas will continue its commitment to Leveled Literacy Intervention (LLI) program this year targeting students who have been determined to need extra help via the benchmarking tool Fountas and Pinnell.
- All needed LLI kits have been obtained including gold, blue, red, green, and orange.
- Lucy Calkins Phonics programs will be implemented in division 1.
- The Readers Workshop kits have been purchased for all grade levels.
- Implement Lucy Calkins' Readers Workshop as a literacy strategy across classes.
  - o Teachers will attend grade specific collaborative planning groups with Literacy Consultant.
- Six of the eight classes are using Raz Kids to support learning.
- Another class set of Chromebooks were purchased to support learning in the grade 3 and 2 classrooms.
- Teachers will attend Writer's Workshop as professional learning becomes available.
- Principal will continue to focus on improving growth and success in literacy through classroom observations and feedback.

## **STRATEGIES:**

- With our consultant's support, Kindergarten to grade 3 will take up the Basic Fact Fluency resource/program to support thinking in mathematics.
- The STAR Math assessment tool will again be used to identify student's levels and abilities. This information is then used to intervene via pullouts with educational assistants to work on missed concepts.
- Elk Island Public Schools consultant is providing coaching and modelling to administration, grade groups and individual students.
- Specific programming includes Number Talks, Guided Math Framework, The CSL Math benchmarking kit and Equals Math kit.
- Uncas Elementary School uses the computer program Mathletics to support delivery of curriculum.

## **MEASURES:**

- The percentage of kindergarten to Grade 3 teachers who are more confident about effectively implementing the new programs of study in mathematics and language arts and literature.
- The percentage of Grade 3 students performing mathematics at grade level.
- The percentage of students who demonstrate 1 year of growth in: STAR Math.
- The percentage of EIPS stakeholders who agree students are demonstrating growth in numeracy.

- Mr. Kennerd will again request Parent Advisory purchase sessions from Saffron in Sherwood Park to address bullying and Internet Safety.
