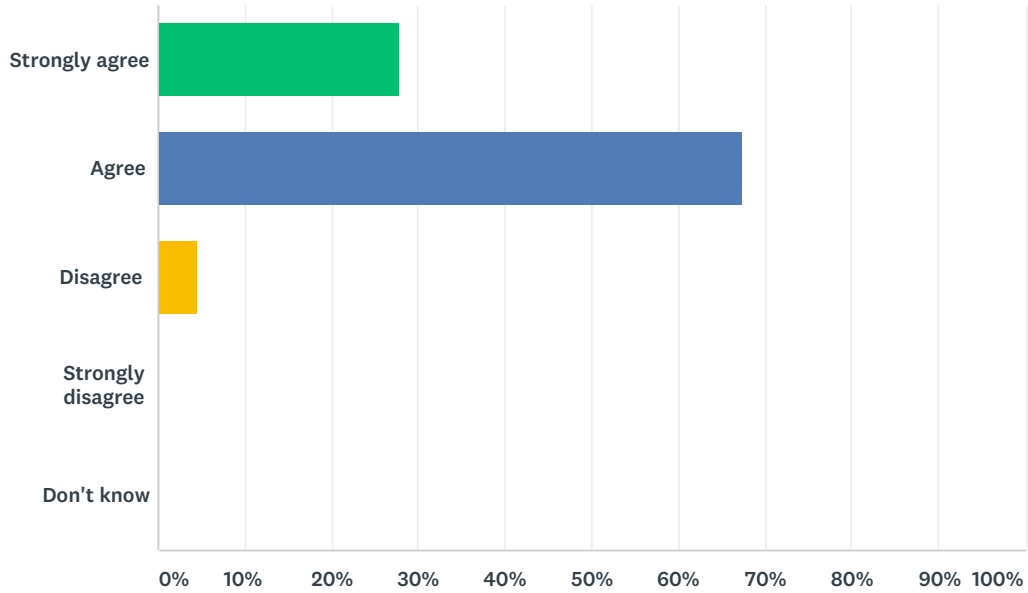

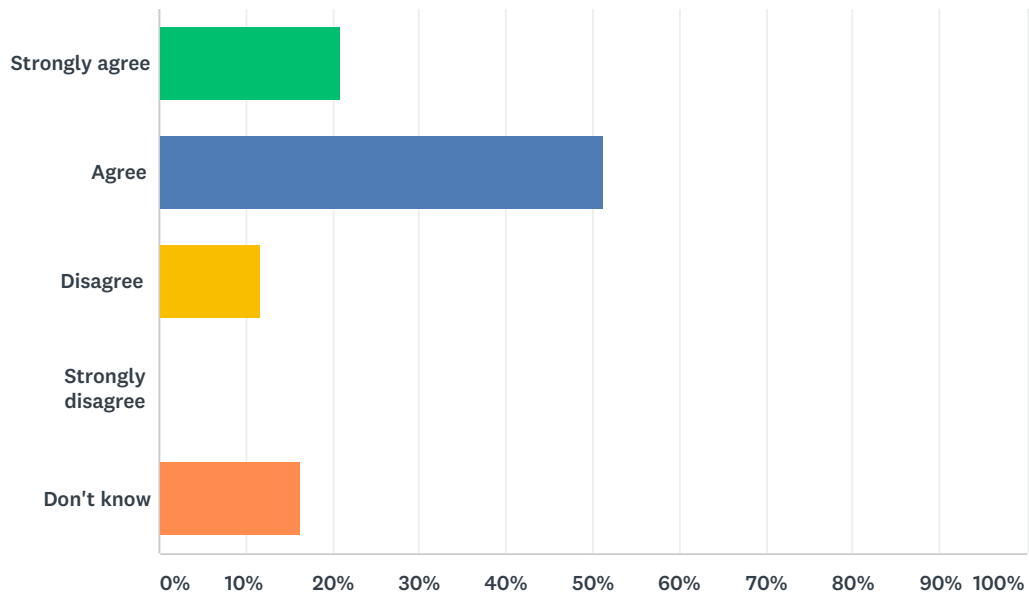

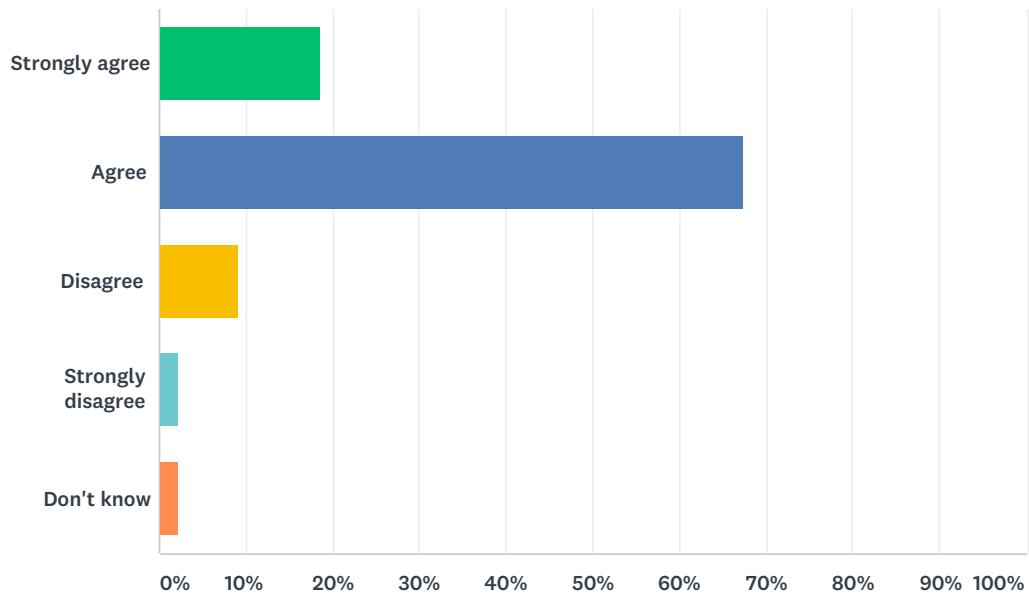

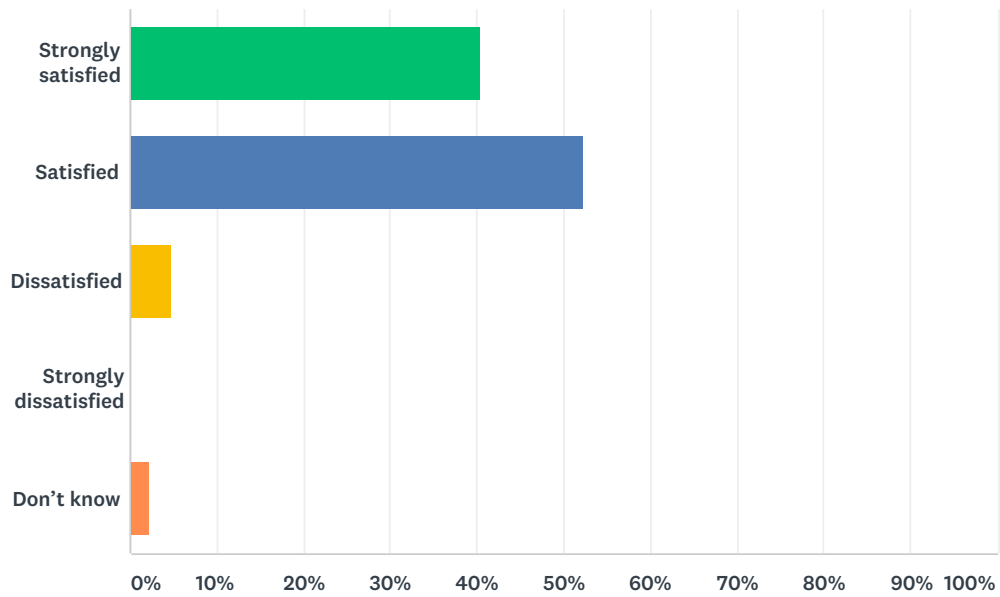

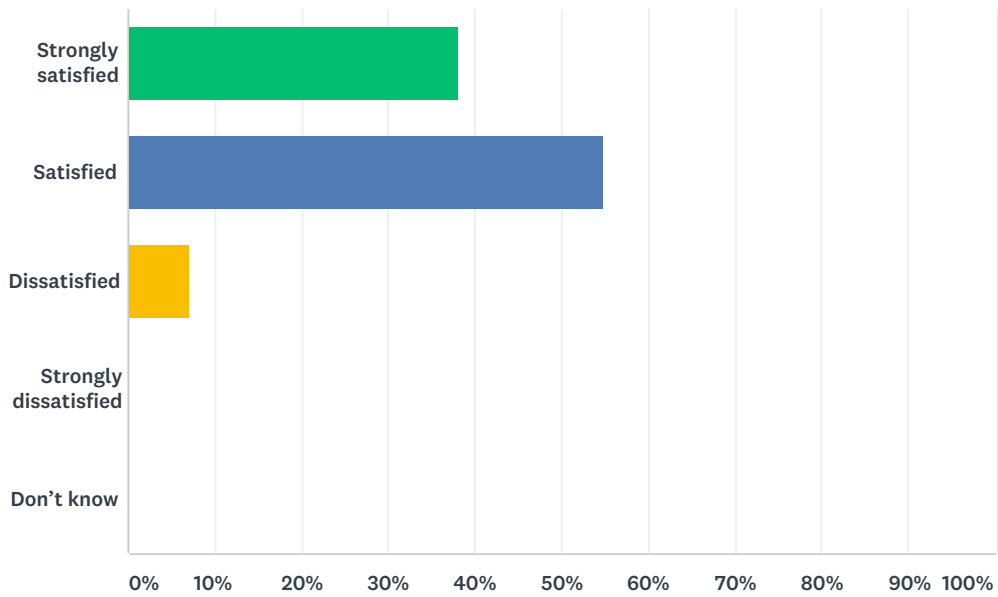

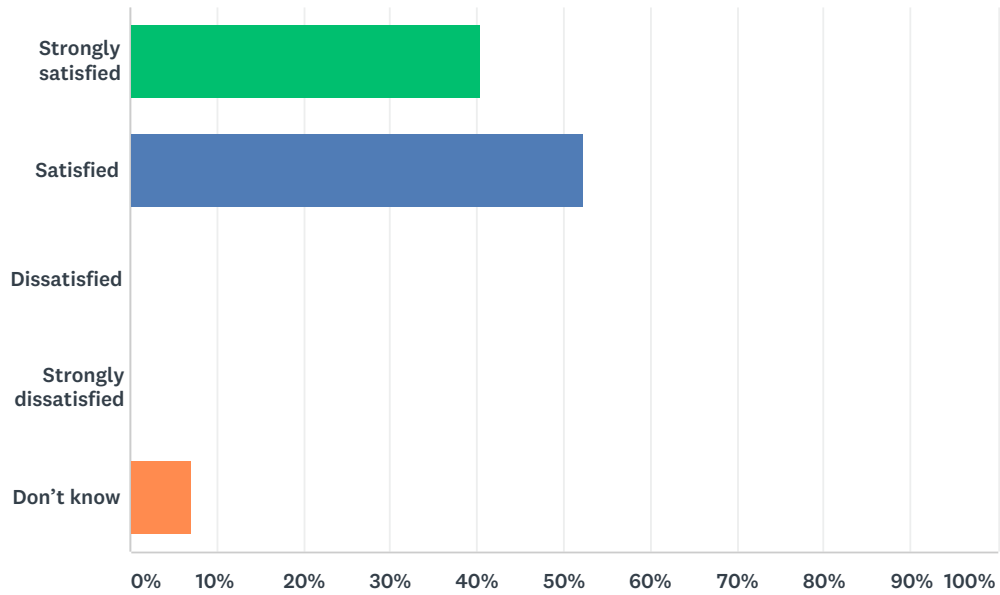

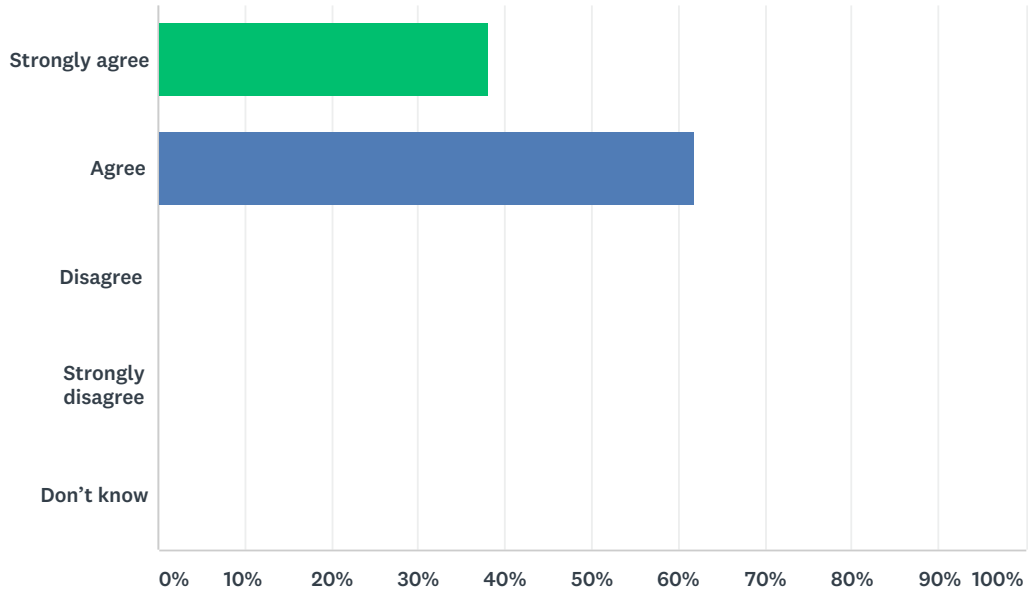

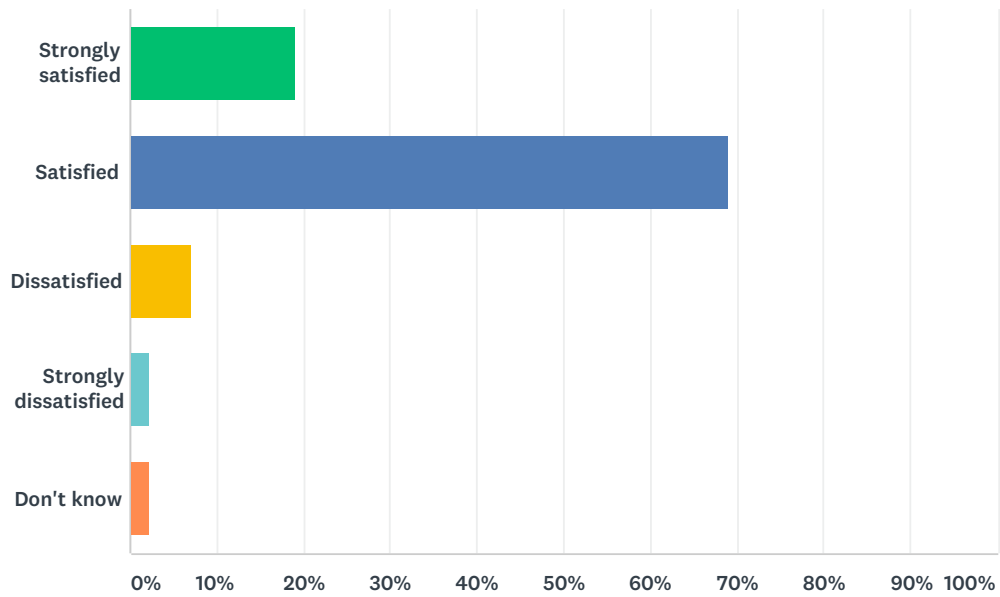

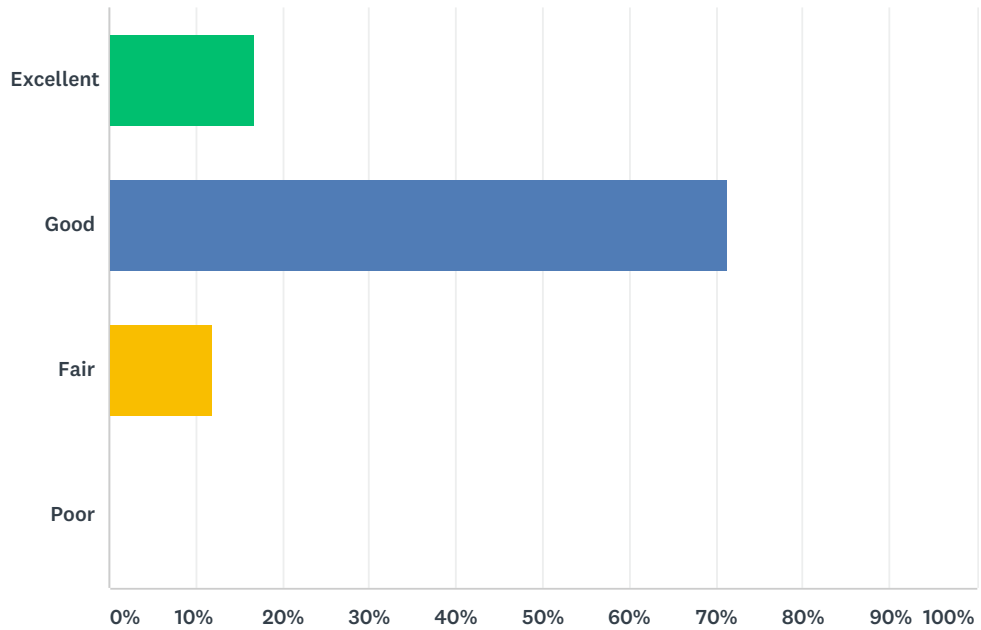

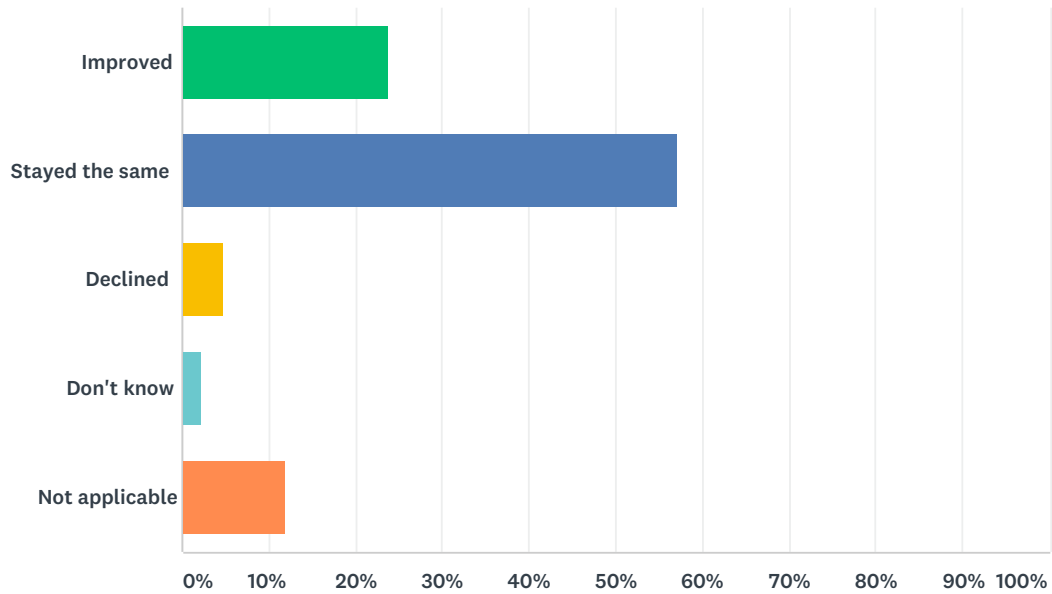

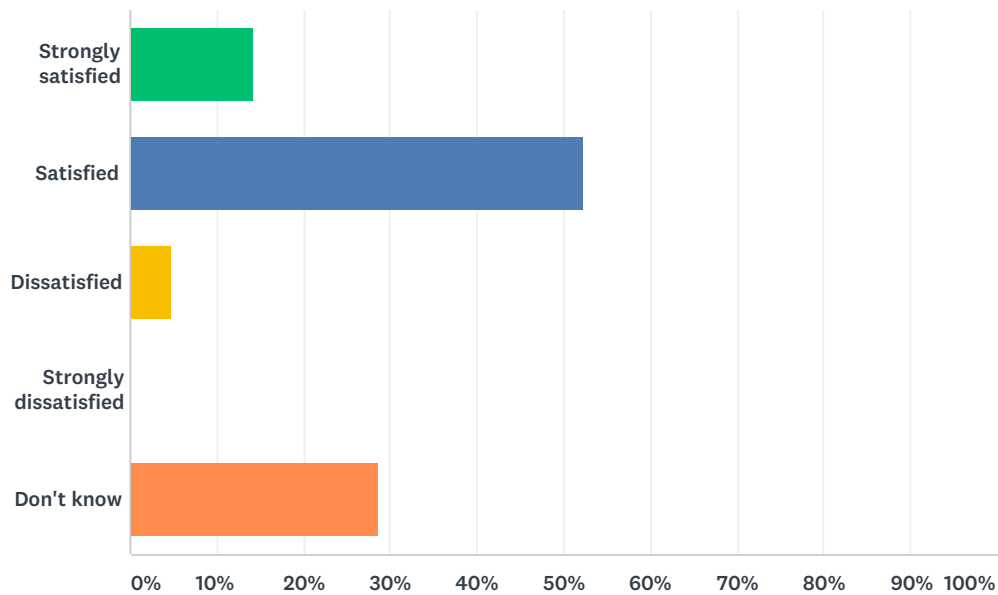

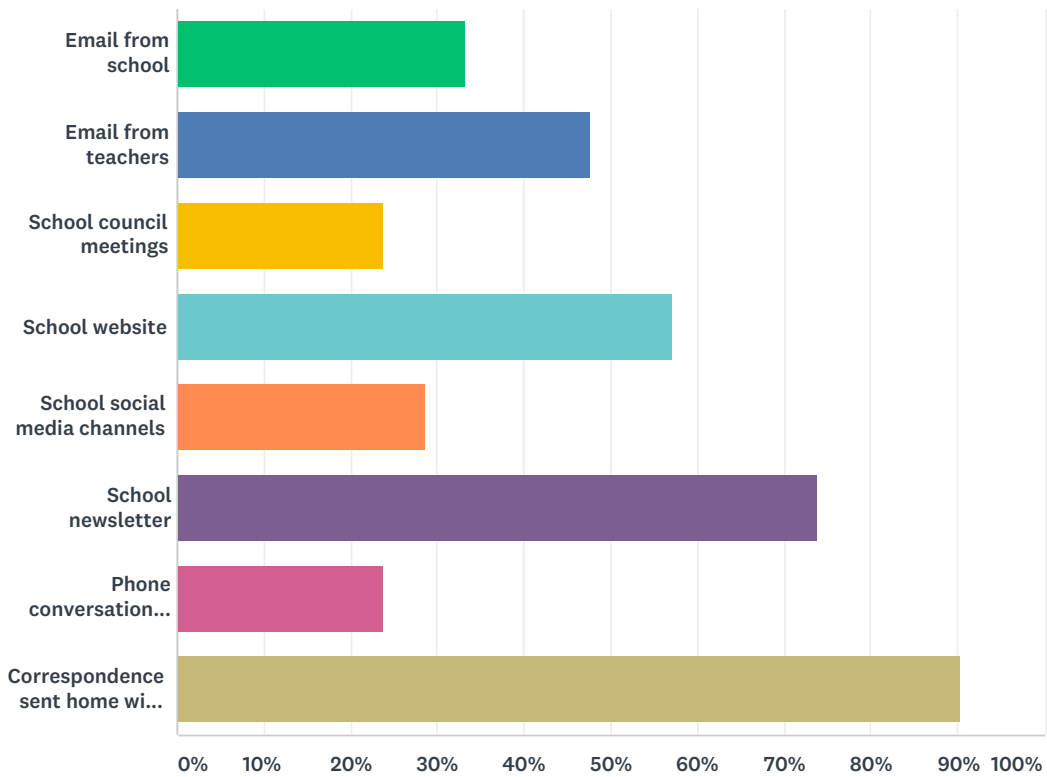

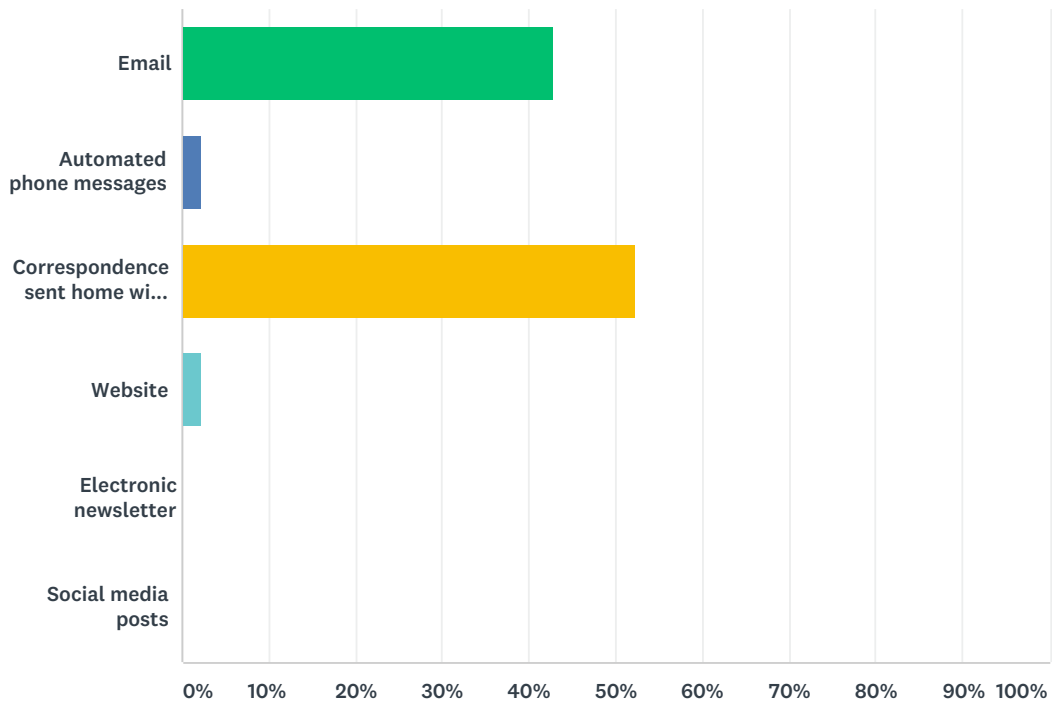

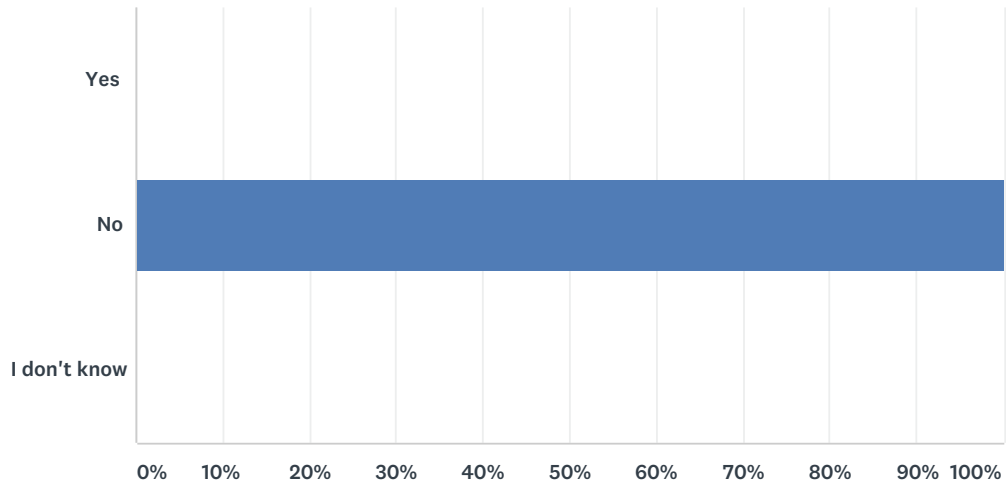

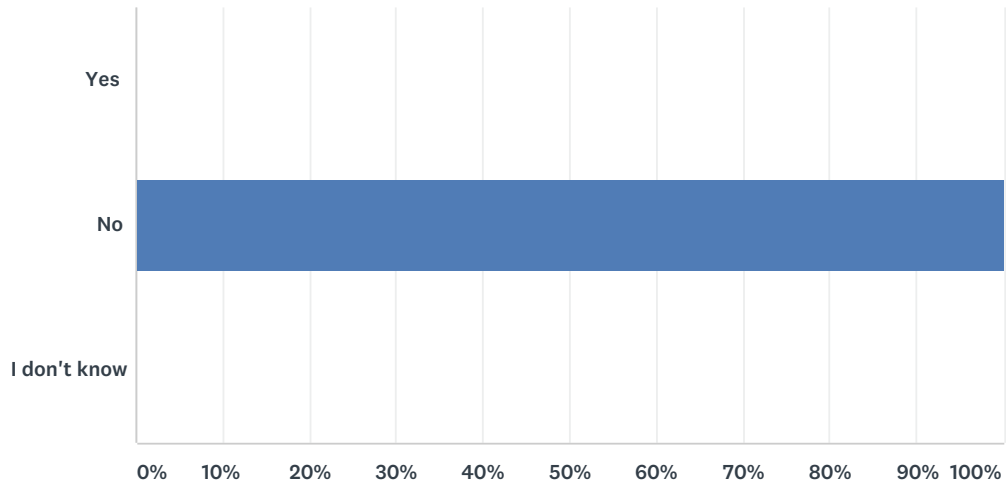

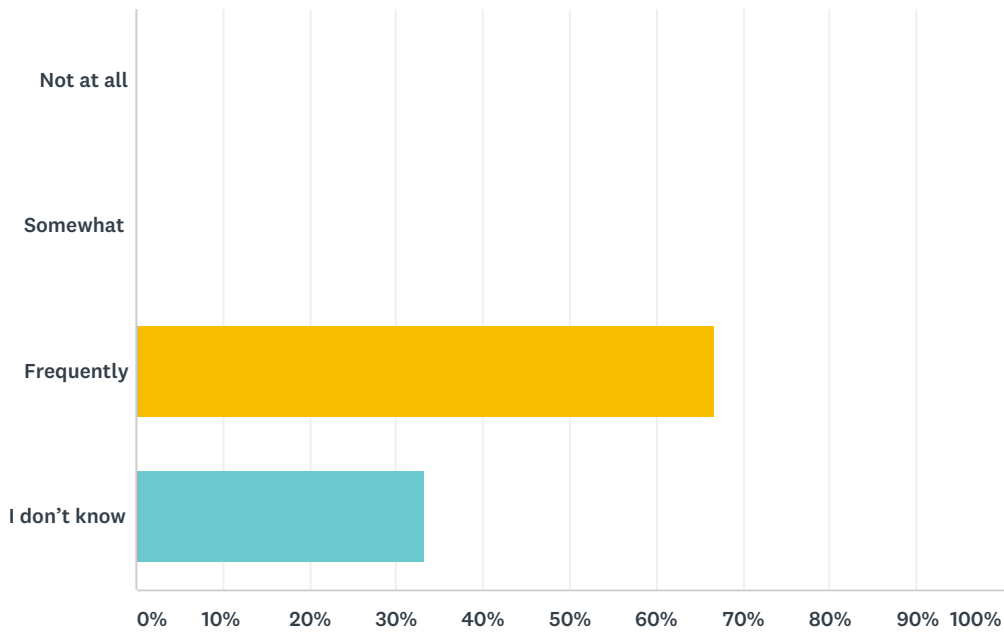

Q35 To what extent do you believe a cellphone or personal device in the classroom distracts your child from learning?

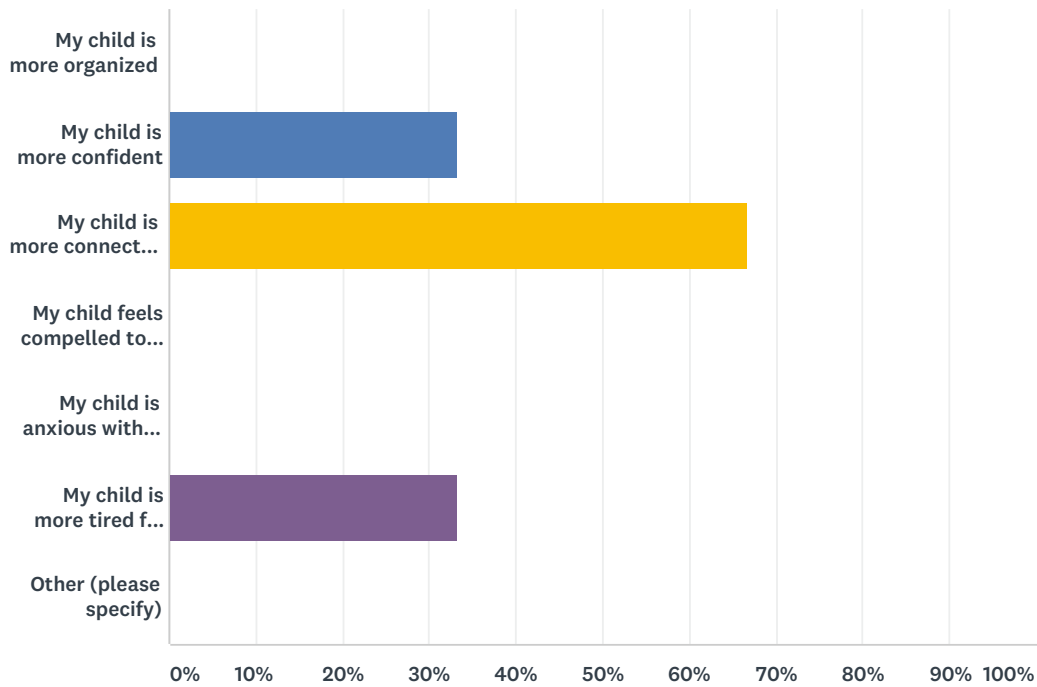

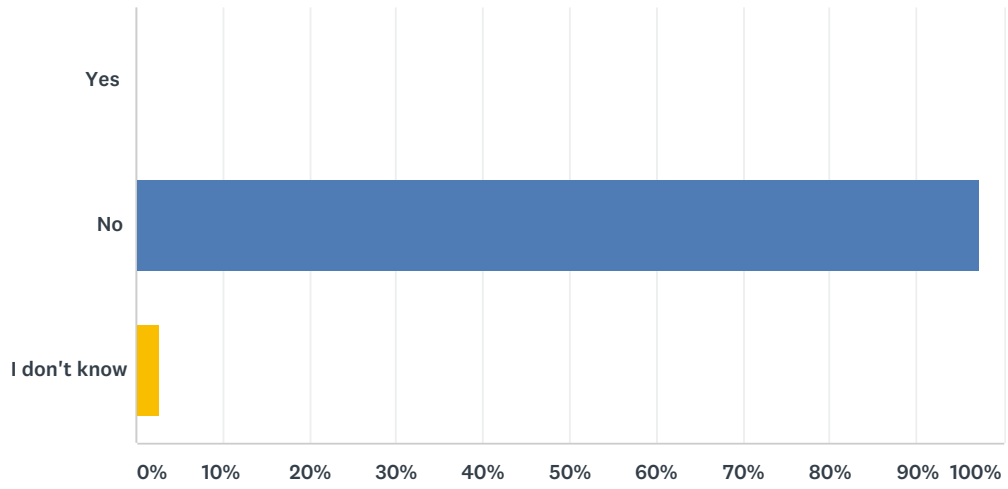
